JUSTIFICATION FOR REAL WORLD TESTING APPROACH

Ilum Insight collects antimicrobial data from facilities to generate compliant data files compliant for NHSN submission. Our Real-World Testing Plan will address two criteria requirements: (b)(10) Electronic Health Information Export, and (f)(6) Transmission to Public Health Agencies – Antimicrobial Use and Resistance Reporting. We will test by reviewing and reporting the number of NHSN report artifacts generated and exported by month for submission. Success is determined by a steady increase of report artifacts generated and exported over time.
